

CONFIDENTIALITY POLICY

This Confidentiality Policy (hereinafter referred to as the Confidentiality Policy) applies to all information posted on the Internet on the Website: <http://akom.su/sites/bi/> (hereinafter referred to as the Site) that Visitors of Site can receive about the User during the use of the Site, its services, programs and products.

Using of the services of the Site means the unconditional consent of the User with this Policy and conditions for processing his personal information specified in it; in case of disagreement with these conditions, the User should refrain from using the services.

1. GENERAL CONDITIONS

1.1. Within the scope of this Policy, the personal information of the User means:

1.1.1. Personal information that the User provides about himself when registering (creating an account) or in the process of using the Services, including the personal data of the User. Information, which is required for the provision of the Services, is marked in a special way. The User at his discretion provides other information.

1.1.2. Data that is automatically transferred to the Website services in the course of their use due to the software installed on the User's device, including IP address, cookie data, information about the User's browser (or other program that accesses the services), technical characteristics of equipment and software used by the User, date and time of access to services, addresses of requested pages and other similar information.

1.1.3. Other information about the User, the processing of which is provided for by the Site Usage Agreement.

1.1.4. This Confidentiality Policy applies only to the Site <http://akom.su/sites/bi/> . The Site <http://akom.su/sites/bi/> does not control and is not responsible for third party Sites to which the User can be transferred using the links available on the Site <http://akom.su/sites/bi/>.

2. PURPOSES OF PROCESSING OF USERS PERSONAL INFORMATION

2.1. The Site collects and stores only that personal information that is necessary for the provision of services or the execution of agreements and contracts with the User, unless the law provides for the mandatory storage of personal information for a period specified by law.

2.2. The Site processes the User's personal information for the following purposes:

2.2.1. Identification of the User, registered on the Site, for the participation of Users in the projects of the Site.

2.2.2. Providing the User with access to the personalized resources of the Site.

2.2.3. Establishing feedback with the User, including sending notifications, requests regarding the use of the Site, the provision of services, processing requests and applications from the User.

2.2.4. Determining the location of the User to ensure security and to prevent fraud.

2.2.5. Confirmation of the accuracy and completeness of personal data provided by the User.

2.2.6. Creating an account to participate in the projects of the Site, if the User has agreed to create an account.

2.2.7. Notification of the User of Site about projects and other information of the Site.

2.2.8. Providing the User with effective customer and technical support in case of problems associated with the use of the Site.

3. TERMS OF PROCESSING OF PERSONAL INFORMATION OF USERS AND ITS TRANSFER TO THIRD PARTIES

3.1. The Site stores Users personal information in accordance with the internal regulations of specific services.

3.2. With regard to the User's personal information, its confidentiality is maintained, except for cases when the User voluntarily provides information about himself for general access of public. When using certain services, the User agrees that a certain part of his personal information becomes open to public.

3.3. The Site has the right to transfer the User's personal information to third parties in the following cases:

3.3.1. User has agreed such actions.

3.3.2. Transfer is necessary for the use by the User of a certain service or for the execution of a specific agreement or contract with the User.

3.3.4. The transfer is provided for by Russian or other applicable legislation within the framework of the procedure established by law.

3.3.5. In the event of the sale of the Site, all obligations to comply with the terms of this Policy with respect to the personal information received by him are transferred to the acquirer.

3.4. The processing of the User's personal data is carried out without any time limit by any legal means, including in personal data information management systems using automation tools or without using such tools. Processing of users' personal data is carried out in accordance with Federal Law dated July 27, 2006 N 152-FZ "On Personal Data".

3.5. In case of loss or disclosure of personal data, the Site Administration informs the User about the loss or disclosure of personal data.

3.6. The Site Administration takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, alteration, blocking, copying, distribution, as well as from other illegal actions of third parties.

3.7. The Site Administration together with the User takes all necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

4. OBLIGATIONS OF THE PARTIES

4.1. User is obliged:

4.1.1. Provide personal data, which are required to the Site.

4.1.2. Update, supplement the provided personal data in case of change.

4.2. Site Administration is obliged:

4.2.1. Use the information received solely for the purposes specified in this Confidentiality Policy.

4.2.2. The Site Administration reserves the right to publish reports on the Site in the Media section, presentations of the participants of the annual international scientific and technical conference "Battery Innovation", scientific and technical projects,

presentations of winners and awardees of the contest “Developer of breakthrough technologies of chemical current sources” and transmitted personal data of the User, except as provided by this Confidentiality Policy.

4.2.3. Take precautions to protect the confidentiality of the User’s personal data in accordance with the procedure usually used to protect such kind of information in existing business transactions.

4.2.4. Block personal data, related to the relevant User, from the moment of appeal or request of the User or his legal representative or authorized body for the protection of the rights of personal data owner for the period of verification in case of revealing inaccurate personal data or illegal actions.

5. LIABILITY OF THE PARTIES

5.1. The Site Administration is liable for losses incurred by the User in connection with the unlawful use of personal data, in accordance with the legislation of the Russian Federation.

5.2. In case of loss or disclosure of confidential information, the Site Administration is not responsible if:

5.2.1. This confidential information became public before its loss or disclosure.

5.2.2. This confidential information was received from a third party until the Site Administration received it.

5.2.3. This confidential information was disclosed with the consent of the User.

6. SETTLEMENT OF DISPUTES

6.1. Before applying to the court with a claim concerning disputes arising from the relationship between the Site User and the Site Administration, it is mandatory to submit a claim (a written proposal for the voluntary settlement of the dispute).

6.2. The receiver of the claim within thirty (30) calendar days from the date of receipt of the claim should notify the claimant in writing of the results of the consideration of the claim.

6.3. If an agreement is not reached, the dispute will be referred to the court in accordance with the current legislation of the Russian Federation.

6.4. The current legislation of the Russian Federation applies to this Confidentiality Policy and to relationship between the User and the Site Administration.

7. AUXILIARY CONDITIONS

7.1. The Site Administration has the right to make changes to this Confidentiality Policy without the consent of the User.

7.2. The new Confidentiality Policy comes into force from the moment it is posted on the Site, unless otherwise provided by the new revision of the Confidentiality Policy.
